Request and Response:

1. How do you currently accommodate care leavers/young people(16-24 years old) within your borough?

We have 16-18+ year olds in fostering and residential care. Some are placed with family members. Others are in supported lodgings and moving on accommodation identified with our housing colleagues, including private landlords.

2. Can you explain your commissioning process for private residential care providers/private supported living providers? Do you spot purchase, have framework contacts/agreement or block contracts?

We currently have preferred providers on a framework contract that we use. Occasionally, we may have to go outside of the framework and spot purchase in order to meet the specific needs of a child/young person.

3. Do organisations need to go through the tendering process to accommodate care leavers/young people(16-24 years old) on a spot purchase basis? If information regarding the website to access will be valuable.

We are currently undertaking a market development exercise prior to tendering for care placements. All current providers are on a framework and new providers can apply to join the framework.

4. Do you operate an approved providers list of private residential care providers/private supported living providers? If so how do I register?

Some 16+ young people are placed with private care providers under a framework (approved provider arrangement). See 3 above.

6. How many care leavers/young people (18 years old and above) are currently in private residential care/private supported accommodation? Do you require more providers?

The average weekly cost for a 16/17 year old in private residential care is £3543.35. Please note that this cost has been calculated on the total weekly amount payed so can include additional costs agreed above the standard basic fee.

10. What is the average weekly cost of placing an adult (18-24 years old) in a private residential care/private supported accommodation?

To the best of our knowledge this information not held.
