Set up fees:

Nb. For items in italics, the fee applied will be determined by whether the property is currently registered or unregistered and in accordance with the equity limit for registered land and the value of the whole property where the land is unregistered. If the applicant no longer wishes to pursue the deferred payment arrangement then costs incurred to the Council will need to be paid
